6.0 BOARD INFORMATION ITEM ABOUT LAO REPORT REDESIGNING ADULT EDUCATION

Mr. Russell presented Board Reps highlights of the Legislative Analyst Office report "Redesigning California's Adult Education Funding Model," which was released the week of December 12, 2022. Highlights from the report:

- Background on K-12 adult education funding: based on attendance prior to 2008-09, the effects of the Great Recession, and the creation of AEBG / CAEP
 - ADA equivalent for adult ed schools was 525 hours, but enrollment caps existed
- Background on noncredit Community College District funding
- Report cited the below drawbacks of the existing funding model:
 - o Current funding is not linked to student attendance / student demand
 - No CAEP or noncredit CCC funding is linked to provider performance
 - o Adult schools charge fees for CTE classes / community colleges do not
 - No CAEP funding is allocated for regional coordination and successful student transitions
 - o CAEP funding is not adjusted annually based on student demand
- The report provided funding scenarios that addressed these drawbacks: funding would be based on attendance and outcomes; funds would also be allocated for consortiumlevel activities based on attendance and outcomes

Board discussions centered on how this report would affect how CCAEC members provide services. Mr. Russell noted that the report called for a five-year phase in. He also noted that many steps would need to occur for this report to actually come into existence: the Governor would need to release the 2023-24 budget to see how that would affect the proposals in this report; the changes would need to attract a legislative sponsor; the field would need to provide input; finally, the changes would need to go to committee. A timeline for all of that would be uncertain.

7.0 BOARD REVIEW OF CCAEC ANNUAL DATA REVIEW

Mr. Russell gave highlights of the CCAEC Annual Data Report focusing on members needing to improve Participation, Persistence, and Gains in CASAS Educational Functioning Level (EFL). He noted that based on the LAO report and CCAEC Three Year Plan improving these outcomes was critical.

8.0 BOARD REVIEW OF CCAEC REGIONAL WORKFORCE DEVELOPMENT PLAN
